Speaker STEVEN PERIAN KC FCIArb



Steven Perian KC FCIArb is a Malaysian practising in the UK. He was called to the UK Bar in 1987 and joined the Crown Prosecution Service in 1989. In 1995, he returned to the Self-Employed Bar. He is a member of Lincoln's Inn and Inner TempleIn 2016, he was appointed Queen's Counsel (King's Counsel). He is a Member of the Panel of Advocates at the International Criminal Court in Hague. He is a Fellow of the Chartered Institute of Arbitrators (UK) dealing with International Arbitration. He is also a Civil Mediation Council Registered Civil and Commercial Mediator. He is an accredited Vulnerable Witness Trainer for Lincoln's Inn and The South Eastern Circuit. He is also an advocacy trainer for Lincoln's Inn. On 30.09.19, he made legal history as the first Malaysian who is a King's Counsel from England and Wales to be called to the Malaysian Bar. He is an accredited Mediator registered with the Malaysian International Mediation Centre. He is constantly recognised in the legal 500 UK as one of the Leading King's Counsel in crime for London. He has extensive experience in prosecuting and defending in the most serious criminal offences which includes: complex fraud, money laundering, murders, sexual offence, gang violence, organised crime, modern day slavery and drug trafficking cases.
